

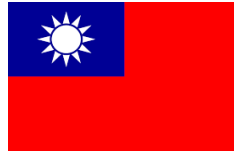
# 來自中華民國的國際扶輪最高職員

## Rotary International supreme officers from the Republic of China

國際扶輪在中華始於 1919 年 7 月，當時在中華民國成立的第一家扶輪社是位於上海公共租界的上海扶輪社。到了 2024 年 7 月，扶輪運動在中華大地開展了一百多年。在這百多年當中，多位中華民國的傑出國民出任了國際扶輪的最高職員。

## 國際扶輪社長、財務長、理事的職責

**社長** -- 身為國際扶輪之最高職員，社長：

- (a) 應為激勵全球社員的積極領導者；
- (b) 應為理事會主席，並主持所有理事會會議；
- (c) 應為國際扶輪的主要發言人；
- (d) 應主持所有國際年會及國際扶輪的其他國際會議；
- (e) 應對秘書長提供建議；及
- (f) 應負起理事會指派之其他職責。

**財務長** --

- (a) 應定期向秘書長取得財務資訊，並與秘書長商量國際扶輪的財務管理事項；
- (b) 應向理事會及國際年會提出適當之報告；及
- (c) 在國際扶輪細則之規定及其身為理事會之理事的職責之外，亦得由社長或理事會指派其他職責。

**理事會之職責** --

### 目的

理事會負責推進國際扶輪的目的，達成扶輪宗旨，研究並教導扶輪之基本原則，並在世界各地保存並擴展國際扶輪之理念、道義及特色。

### 權力

理事會以下列方式指揮並掌管國際扶輪事務：

- (a) 制定組織之政策；
- (b) 評估秘書長執行政策之績效；
- (c) 理事會應對國際扶輪所有職員、職員當選人、職員提名人及各委員會行使掌管與督導權；及
- (d) 執行章程、細則和伊利諾州 1986 年一般非營利法人法案，及其後之修訂賦予理事會的其他權力。

### 策略計畫

理事會應採行策略計畫，並在每屆立法會議報告策略計畫之進展。各理事應在選出該理事之地帶及配對地帶，督導並執行策略計畫。

## Duties of the Rotary International President, Treasurer, and Directors

**President** -- The president, as the highest officer of RI, shall:

- (a) be a positive and motivational leader for Rotarians worldwide;
- (b) be the chair of the board and preside at its meetings;
- (c) be the principal person to speak for RI;
- (d) preside at all conventions and other international RI meetings;
- (e) counsel the general secretary; and
- (f) have further duties and responsibilities as assigned by the board.

**Treasurer** -- The treasurer:

- (a) shall regularly receive financial information from, and confer with, the general secretary on the management of RI finances;
- (b) makes appropriate reports to the board and the annual convention; and
- (c) may have additional duties to those in the RI bylaws or that accompany membership on the board as assigned by the president or the board.

### Board of Directors

**Purpose** -- The board is responsible for doing whatever may be necessary for the furtherance of the purposes of RI, the attainment of the Object of Rotary, the study and teaching of its fundamentals, and the preservation and extension of RI's ideals, ethics, and unique features throughout the world.

**Powers** -- The board directs and controls the affairs of RI by:

- (a) establishing policy for the organization;
- (b) evaluating implementation of policy by the general secretary;
- (c) exercising control and supervision over all officers, officers-elect, officers-nominee, and RI committees; and
- (d) exercising other powers conferred by the constitution, the bylaws, and the Illinois General Not-for-Profit Corporation Act of 1986 and their amendments.

**Strategic Plan** -- The board shall adopt a strategic plan and report on it at each council on legislation. Each director shall oversee the implementation of the strategic plan within the zone from which the director was elected and its paired zone.
