Home of Many Honorary Doctorates and Fellows

The month of July in the year 2019 marks the 100 years of Rotary development in the greater China since the inception of the Rotary Club of Shanghai (上海扶輪社) in 1919. Within the 13 districts and 1 non-districted group of the Great Chinese Region, the Rotary Club of Hong Kong (香港扶輪社) which was chartered in 1931, is still the oldest with the longest of more than 80 years continuous regular meetings of which holding an average of around 100 members every year. Other than numerous service projects launched locally and internationally, this Club has been and is still the home of many eminent Rotarians, including:

- (1) 2 Rotarians served as Member of the International Olympic Committee;
 - (2) 5 Rotarians had been chiefs of the St. John Ambulance Organization in Hong Kong;
 - (3) 4 Rotarians were either President or Chief Commissioner of the Hong Kong Scouts;
 - (4) 2 Rotarians had served the law enforcement as voluntary Commandant of either Hong Kong Police Reserve Unit or the Royal Hong Kong Auxiliary Police Force;
 - (5) One Rotarian chaired the Hong Kong Urban Council (香港市政局) for 8 years, plus 12 Rotarians had served as members of the Council;
 - (6) 9 Rotarians sit in the Hong Kong Executive Council (香港行政局);
 - (7) 15 Rotarians sit in the Hong Kong Legislative Council (香港立法局) as lawmakers;
 - (8) 12 members had served Rotary International as Vice-President, Director, Administrative Advisor, District Governor;
 - (9) 12 Rotarians had been invested Knights Bachelor (下級勳位爵士) by the British sovereign;
